Mr. Titus is a 63-year-old US Army veteran who has lived in his family home in Moss Point his entire life with the exception of the time of his military service. The house is well over 50 years old and has been maintained as best as possible by Mr. Titus given his limited Social Security income, VA pension, and physical limitations. The flooring was literally sinking, and the only bathroom's toilet was leveled by a brick. Thanks to the HFHMGC weatherization and veteran repair programs Mr. Titus was able to receive a complete bathroom remodel, HVAC servicing, and attic insulation (to help reduce heating and energy costs). While this work definitely increased the safety of Mr. Titus' home he could truly benefit from a complete flooring system overhaul as his home has more serious structural flooring issues than either program could address.

Your gift will provide tools and resources to assist these families who need a safe affordable home. By reading the impact above, I hope you will continue to support Habitat for Humanity of the Mississippi Gulf Coast. Together, we can do so much.
